### Yearly Membership fees for full members

Based on business turnover in million Euros<sup>4</sup>

250 €	< 500.000
500 €	500.000 to 1 Mio.
1.000 €	1 to 10 Mio.
2.000 €	10 to 25 Mio.
3.000 €	25 to 50 Mio.
4.500 €	50 to 150 Mio.
6.000 €	150 to 300 Mio.
7.500 €	300 to 500 Mio.
9.000 €	> 500 Mio.

Producer unions, -associations or umbrella associations of producers are generally charged 4.500 EUR (if their members' business turnover is higher than 300 M EUR) or 2.500 EUR (if their members' business turnover is lower than 300 M EUR). If more than 5 members of an association become members of the Donau Soja Association, the fee will be reduced to 2.250/1.250 EUR respectively.

Membership fees of the Austrian Soya Association and of ARGE Gentechnik-frei Association will be deducted from membership fees.

In case the turnover increases/decreases, the membership fee must be adapted to the above table. Donau Soja is empowered to change the above table at any time. These changes have to be announced written only to the Member.

### Membership fees of associate members

Membership fees of associate members amount to 3.500 EUR. Exceptions based on a reasonable request (in case, the membership is important for the association) can be made by the board.

Membership fees of the Austrian Soya Association and of ARGE Gentechnik-frei will be deducted from membership fees.

Non-profit organisations, associations and umbrella associations of non-profit organisations are free of membership fees.

The membership fee must be paid annually (once per calendar year).

<sup>4</sup> If the full member is part of a concern or group of companies, membership fees are based on the turnover of the concern or group of companies as stated in the last consolidated balance sheet, or in the absence of a consolidated balance sheet of the combined turnover of all concern companies. In case the full member is not part of concern, membership fees are based on the business turnover of the last published annual balance sheet.
