

Info Sheet EU Deforestation Regulation (EUDR) & Donau Soja

Background EUDR

On 19 April 2023, the EU Parliament adopted the EU Deforestation Regulation (EUDR). The next step is for the EU Council to officially approve it.

After a transitional period of 18 months, the first distributors of the commodities soya, beef, palm oil, wood, cocoa, coffee and rubber, on the EU market, must prove that the raw materials were produced legally (according to the laws of the country of cultivation) and deforestation-free with a cut-off date of 2020. This applies to imports into the EU but also the production in EU countries. There are still many open questions regarding the implementation of the requirements, which are planned to be answered in expert groups in the coming months. The information required for the so-called due diligence statements is already laid down in the law text.

Donau Soja & the EUDR

For the cultivation of Donau Soja and Europe Soya certified soya, in the EU and in non-EU countries, the legality as well as deforestation- and conversion-free cultivation with a cut-off date of 2008 is proven.

Through segregated supply chains and our traceability certificates, this information can be passed along the value chain.

Thus, the use of Donau Soja / Europe Soya contributes to compliance with the upcoming legal requirements.

The following table shows the information Donau Soja (DS) and Europe Soya (ES) can provide required for the EUDR due diligence statement:
