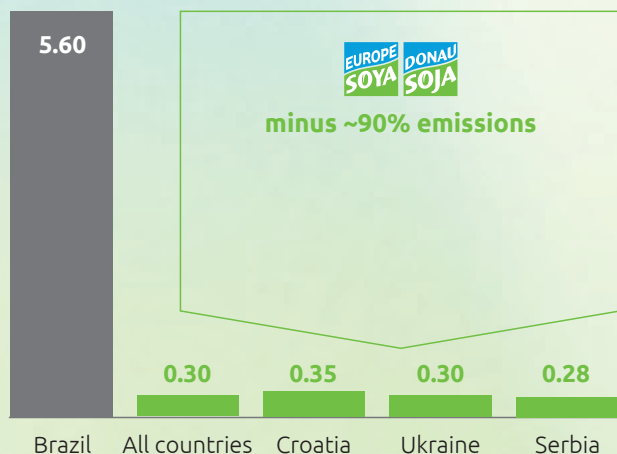
The Donau Soja and Europe Soya quality

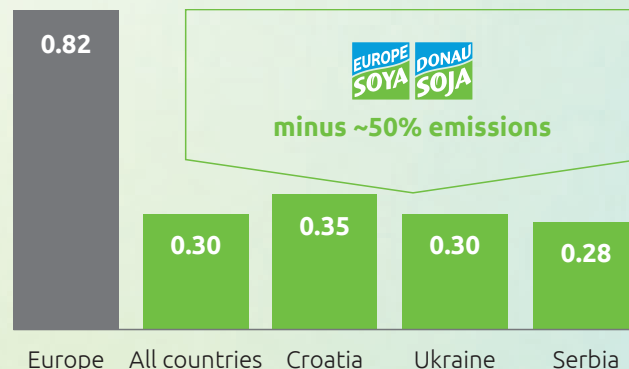
CARBON BENEFITS OF DONAU SOJA FROM UKRAINE

Cultivation of Donau Soja and Europe Soya generates 90% less carbon emissions compared to the average non-certified Brazilian soy.

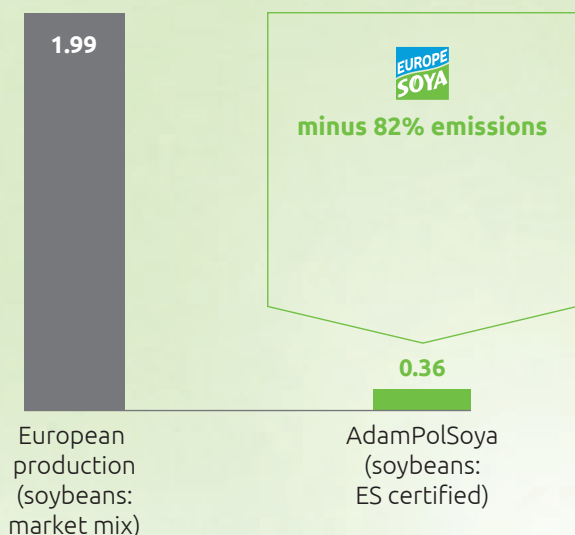

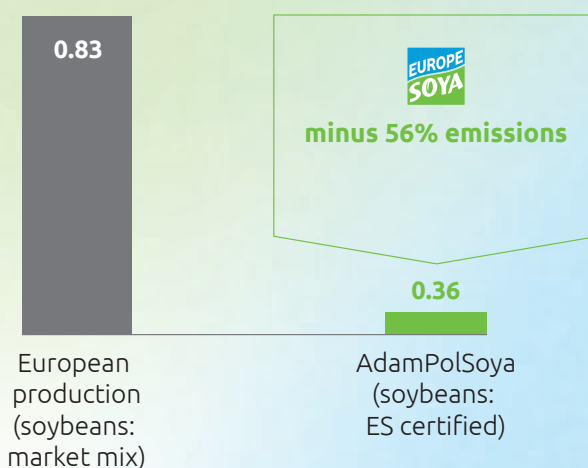


CARBON FOOTPRINT DATA OF ADAMPOLSOYA CERTIFIED SOYMEAL:

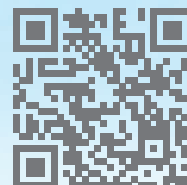

The European Union has introduced Regulation (EU) 2023/1115 aimed at preventing the import of goods associated with deforestation and forest degradation.

The Donau Soja Protein Partnership Programme supports agricultural producers to certify soybeans for compliance with EU high-level production & sustainability rules. Another important goal of the Programme is to create a level playing field for farmers in Europe.

With our Protein Partners in Ukraine, Donau Soja started the pilot projects in 2023 aimed to be well prepared for the EUDR implementation.

Donau Soja has commissioned the Land Use Change verification for 100% of the field plots of the certified partners, based on the satellite images. Donau Soja continues the same project for the harvest 2025.

After the soya harvest in 2025, certified producers from Ukraine and Moldova will be able to provide:

- **The geo-locations of soya fields** via Donau Soja IT traceability System;
- **Deforestation-free (2020) verification** — based on satellite image analysis;
- **Legality** — via the inspection checklist for audits;
- **Donau Soja/Europe Soya certificate;**
- Additionally: **conversion-free (LUC) verification (2008)**. *Cultivation of Donau Soja and Europe Soya generates **50% less** carbon emissions compared to the average non-certified European soybeans.*

KEY FEATURES OF THE EU DEFORESTATION REGULATION (EUDR)

The EUDR applies to soya and its processed products. Annex I of the EUDR defines which products are covered and can be compared using Harmonised System Codes:

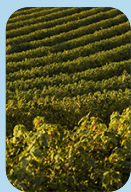
- 1201** Soya beans.
- 1208 10** Soya bean flour.
- 1506** Soya bean oil and its fractions, whether or not refined, but not chemically modified.
- 1506** Oilcake and other solid residues resulting from the extraction of soya bean oil, whether or not ground or in the form of pellets, resulting from the extraction of soya-bean oil.

The regulation is applicable from **December 30, 2025** — impacting this year's soya harvest. From now on, it will be impossible to legally import any ton of soya into the EU without fulfilling the following conditions:

- **Country of cultivation and Harvest Date** (Article 9 [c] and [d] EUDR);
- **Confirmation of no deforestation after 2020 on these fields** (Article [g] EUDR);
- **Traceability of each batch of the product** to the field where it was grown (Article 9 [d] EUDR);
- **Confirmation of the legality of production** (Article 9 [h] EUDR).

The regulation applies to goods and processed products that can cause deforestation:

soya, cocoa, palm oil, cattle, coffee, rubber, timber.
